### What is the role of the board?

The role of the board is to set the direction, policies and priorities of the Guild as representatives of the general membership. The board sets the direction of the Guild, which the Executive Director puts into action. As such, the board does not carry out day-to-day programs and operations, but monitors these so that they reflect board policies. The board must also approve the financial statements and set the budget for the year.

*To inspire, connect, support, encourage and promote writers and writing, to safeguard the freedom to write and to read, and to advocate for the well-being of writers.*

### What is the board meeting schedule?

The board conducts much of its business through monthly teleconference meetings that are held on weekday evenings. Each meeting typically lasts 90 minutes and requires a few hours preparation. The board also calls one face-to-face meeting throughout the year. Board committees meet separately as required.

### How long does a board member serve?

Board members are elected for two-year terms and may hold office for a total of four consequent years, except in the case of the Past President, who can serve a fifth year in that role.





The WGA represents the literary community to all levels of government.

## How does the WGA choose its board?

The Board of Directors is elected by the membership at the Annual General Meeting. Directors are normally elected by a majority of members in attendance, personally or by proxy. The candidates with the largest number of votes then fill director vacancies. If a board vacancy occurs mid-year, the Board of Directors may fill it from the membership until the next Annual General Meeting.

The board includes the following positions:

- President
- Vice-President
- Secretary
- Treasurer
- Immediate Past President
- Five (5) members-at-large, including a youth board member

## Board committee work

Each board member is strongly encouraged to participate in at least one committee. Committees can be made up of directors, non-board WGA members, staff and community members. Committees change from year to year depending on the needs of the Guild. The following describes our current standing committee.

### Youth Committee

The Youth Committee identifies youth needs, initiatives, and programming and establishes an ongoing liaison between youth members and the board.

## **Board responsibilities**

- Be a member of the Writers' Guild of Alberta.
- Be an active and committed participant in the affairs of the Guild.
- Be involved at board meetings: read minutes and other documents in advance, ask questions, discuss, participate in decision making, react to ideas, and exercise initiative.
- Be regular and punctual at all board meetings; if unable to attend, give early notice to the President.
- Keep informed about the background of issues in order to discuss them responsibly.
- Acquire and maintain a clear understanding of the Guild's financial position.
- Be willing to take an active role on one or more board committees or task groups. Know and maintain the lines of communications.
- Participate energetically in recruiting new board members.
- Support and participate in fundraising.
- Maintain board business confidentiality regarding items discussed *in camera*.
- Contribute to the annual report.
- Keep files up-to-date and hand over all documents to your successor promptly and in good condition.
